- **3M™ Medical Necessity** – standalone editing for outpatient services, including Medicare national coverage determinations (NCDs), local coverage determinations (LCDs), and frequency, age and gender restrictions; ICD-10 diagnosis code and modifier validity; and other state Medicaid and payer-specific edits.
- **3M™ Pricer Tables** – intended for use by payers and other organizations that process claims from multiple providers, 3M Pricer Tables provide facility-specific variables for all applicable providers and are currently available for all Medicare solutions, TRICARE Outpatient Prospective Payment System (OPPS) and most **3M™ All Patient Refined Diagnosis Related Group (APR DRG)** and **3M™ Enhanced Ambulatory Patient Group (EAPG)**-based Medicaid reimbursement methodologies.

The 3M GPCS interactive module allows customers to process an individual patient record and generate grouping results, estimated reimbursement and edits using a web browser. Users manually enter claims data, view results on the screen and generate a report to print or save.
