**Precautions:** The product can increase the adhesion of some adhesive products (e.g., vascular access dressings), particularly in the first few days of use. When removing an adhesive product, it is important to exercise care. Use an adhesive remover containing HMDS to remove an adhesive product (including 3M acrylic negative pressure drapes) that has been placed over the film. This is especially important for patients with fragile skin.

\*If using a securement dressing containing Chlorhexidine Gluconate (CHG), do not apply film to skin intended to come in contact with the CHG gel pad.
